GUIDELINES

- Applicant should be an Art or Art Education major or others identified by Art faculty who have the talent and ability to transfer to a four-year university and Major in an Art related field.
- Must demonstrate financial need
- Must maintain a 2.5 GPA while enrolled at college
- Applicants must be a freshman or sophomore level student
- Must agree to showcase artwork in the Learning Resource Center exhibit during the Spring term in consultation with Art faculty
- Required to submit a brief 3 paragraph essay outlining personal goals, financial need, and how the scholarship will meet these things
- Applicant is required to submit the 2022-2023 Free Application for Federal Student Aid by February 25, 2022 to determine financial need
- If FAFSA is not submitted, applicant is required to submit copy of 2020 Federal Tax Return for student (and parent(s) if student is dependent)

OVERVIEW

The purpose of this scholarship is to provide financial assistance to eligible students with an Art or Art Education major or others identified by Art faculty, enrolled at Olney Central College. Funds are provided by the Olney Central College Foundation through the Mary Lou Brown Art Scholarship Fund. Scholarship may be used for tuition, art supplies, books and fees.
